
### **Diocesan Child Safeguarding Prayer**

## From Bishop Drennan's Desk



The Catholic Church in Ireland has responded in three ways to the sexual abuse crisis. It put in place the **TOWARDS HEALING PROGRAMME** to provide a professional counselling service for those who were abused by Church Personnel. In 2013 over 131,000 counselling hours were given. Feedback has been very positive.

The **TOWARDS PEACE INITIATIVE** has been launched. The launch for the West was in Knock on June 3rd. The service will give support and guidance for those whose faith was damaged by their experience of abuse.

The **NATIONAL BOARD**, whose office is located in Maynooth, has developed **GUIDELINES FOR THE SAFEGUARDING** of children.

To support them this diocese intends to develop a policy on the safe use of the internet. The writing of the policy is work in progress right now. This policy will compliment the policies of the use of webcam and photography already in place.

## From the Director of Safeguarding: Mr. Kevin Duffy

Twelve months ago the Diocese of Galway, Kilmacduagh & Kilfenora underwent an audit by the National Board for Safeguarding Children in the Catholic Church in Ireland (NBSCCCI) and following their recommendations this Diocese has made every endeavour to ensure the successful implementation of these proposals. This led to the enhancement of the existing safeguarding policies surrounding Children and Young People and also allowed for the introduction of new more robust procedures in order to keep abreast of ever changing developments, particularly in the area of electronic equipment and communication.

As the world we live in is never static the Diocese has introduced dynamic new policies and procedures relating to the use of Webcams and Photography within our parishes. These policies will provide greater clarity on the use of such equipment and will also provide safeguards for Children and Young People taking part in church related activities.

## Training in Child Safeguarding Practice

At our last training in January 2014 a **total of 22 people** were presented with the newly revised Child Safeguarding training course designed by the National Board for Safeguarding Children.

We noticed from the returned parish audits that there have been a number of changes in safeguarding personnel at parish level. We would strongly encourage new members of parish safeguarding teams to avail of our next training due to take place in the **Diocesan Pastoral Centre on November 15th 2014.**



Our communications plan will include making available the latest edition of the Diocesan Safeguarding Policy, updated training, newsletters, resource publications and the Annual Conference.



